GULF SHORES CONDOMINIUM ASSOCIATION, INC., its address being c/o Keys Caldwell, 1162 Indian Hills Blvd, Venice, FL 34293, Sarasota County, by the hands of the undersigned hereby certify that:

The Declaration of Condominium of GULF SHORES CONDOMINIUM ASSOCIATION, INC. is recorded in O.R. Book 953, page 1562, et seq., of the Public Records of Sarasota County, Florida. The following amendments to the Bylaws were submitted to the entire membership of the Association at its meeting called and held on the 20th day of February, 2007, and approved by affirmative vote in excess of sixty-six percent (66%) of the total membership of the Association as required by the Bylaws.

- Article 2.3, Members' Meetings, Notice, is hereby amended to read as follows:
  - 2.3 Notice. Written notice of the annual membership meeting shall be given to each unit owner and shall be posted in a conspicuous place on the condominium property at least 14 thirty (30) days prior to the annual meeting. Unless a unit cwner waives in writing the right to receive notice of the annual meeting by mail, the notice of the annual meeting shall be sent by mail to each unit owner. An officer of the association shall provide an affidavit, to be included in the official records, affirming that a notice of the annual meeting was mailed or hand delivered, in accordance with this provision, to each unit owner at the address last furnished to the association. Notices to all other Special Members' Meetings shall be given by regular mail with fourteen (14) days notice, unless waived in writing by the voting owner.
- Article 6.2, Fiscal Management, paragraph (e), Budget, is hereby amended to read as follows:
  - 6.2 <u>Budget</u>. The Board of Directors shall adopt a budget for each calendar year that shall include the estimated funds required to defray the common expenses and to

provide and maintain funds for the foregoing accounts and reserves according to good accounting practices as follows:

e. "BUDGET" Copies of the proposed budget and assessment shall be transmitted to each member no less than sixty (60) thirty (30) days prior to the Annual Members' Meeting. Each budgeted item shall show the amount that was budgeted for such item in the previous budget for comparison purposes. If the budget is amended subsequently, a copy of the amended budget shall be furnished to each unit owner.
